11	Q.	Where is that located?
12	Α.	The office for Kris Kampsen is over here
13	(indicati	ng).
14	Q.	Right on the second floor?
15	А.	Yes.
16	Q.	Does it take up the entire second floor?
17	Α.	Yes.
18	Q.	Is the door to his office ever locked?
19	Α.	No.
20	Q.	And in his office is there any alcohol?
21	Α.	Yes.
22	Q.	What kind of alcohol?

25	MS. COLLINS: Objection, calls for hearsay.
