SECRET INDICTMENT

The above-named defendant is accused by the Grand Jury of Josephine County, by this Indictment of the following offense(s):

- Count 1 - Custodial Sexual Misconduct in the Second Degree
- Count 2 - Sexual Abuse in the Third Degree
- Count 3 - Custodial Sexual Misconduct in the Second Degree
- Count 4 - Sexual Abuse in the Third Degree
- Count 5 - Custodial Sexual Misconduct in the First Degree
- Count 6 - Custodial Sexual Misconduct in the Second Degree

committed as follows:

Count 1 - (ORS 163.454 - A Misdemeanor)

The defendant, on, about, or between April 1 2014 to April 14, 2014, in Josephine County, Oregon, did unlawfully and knowingly engage in sexual contact with Tyler Kane Watson, defendant knowing that such person was confined or detained in a correctional facility and/or on probation, parole, post-prison supervision, conditional release or supervised release and while defendant was employed by a state agency that was responsible for supervising the said victim in or on a work crew, a work-release program, probation, parole, post-prison supervision, conditional release or supervised release.

Count 2 - (ORS 163.415 - A Misdemeanor)

The defendant, on, about, or between April 1, 2014 to April 14, 2014, in Josephine County, Oregon, did unlawfully and knowingly subject Tyler Kane Watson, a person under 18 years of age, to sexual contact by touching his penis, a sexual or intimate part of Tyler Kane Watson.

Count 3 - (ORS 163.454 - A Misdemeanor)

The defendant, on, about, or between April 1, 2014 to April 14, 2014, in Josephine County, Oregon, did unlawfully and knowingly engage in sexual contact with Tyler Kane Watson, defendant knowing that such person was confined or detained in a correctional facility and/or on probation, parole, post-prison supervision, conditional release or supervised release and while defendant was employed by a state agency that was responsible for supervising the said victim in or on a work crew, a work-release program, probation, parole, post-prison supervision, conditional release or supervised release.

The State further alleges the above described offense is separate and distinct from that alleged in count 1.

Count 4 - (ORS 163.415 - A Misdemeanor)

The defendant, on or about April 16, 2014, in Josephine County, Oregon, did unlawfully and knowingly subject Tyler Kane Watson, a person under 18 years of age, to sexual contact, by causing the said Tyler Kane Watson to touch the defendant's vagina, a sexual or intimate part of the defendant.

The State further alleges the above described offense is separate and distinct from that alleged in count 2.

Count 5 - (ORS 163.452 - C Felony)

The defendant, on, about, or between April 15, 2014 to May 10, 2014, in Josephine County, Oregon, did unlawfully and knowingly engage in deviate sexual intercourse with Tyler Kane Watson, defendant knowing that such person was confined or detained in a correctional facility and/or on probation, parole, post-prison supervision, conditional release or supervised release and while defendant was employed by a state agency that was responsible for supervising the said victim in or on a work crew, a work-release program, probation, parole, post-prison supervision, conditional release or supervised release.

Count 6 - (ORS 163.454 - A Misdemeanor)

The defendant, on, about, or between April 15, 2014 to May 10, 2014, in Josephine County, Oregon, did unlawfully and knowingly engage in sexual contact with Tyler Kane Watson, defendant knowing that such person was confined or detained in a correctional facility and/or on probation, parole, post-prison supervision, conditional release or supervised release and while defendant was employed by a state agency that was responsible for supervising the said victim in or on a work crew, a work-release program, probation, parole, post-prison supervision, conditional release or supervised release.




