I never intended, as can be seen from my moving papers, to use Paige's attendance to be a factor in the scheduling of Mr. Forte's trial. I intentionally did not want to raise the need to attend both championships as factors in trial settings, as I personally considered that too much to ask, and I did not. Mr. Forte's effort to push that excuse on me was not my doing, and not my intention.
